The process of becoming a PCFD volunteer is to complete the application in its entirety. Include all names, telephone numbers, and addresses, etc. A background and driving record check will be conducted with this information. A valid Missouri driver's license copy must be submitted. Following these instructions will advance your application and enroll you in an interview process and in an upcoming training and firefighter class.

The objective of the firefighter class is to provide each applicant with the minimum training required to function as a member of this department. It will cover both classroom and practical training that will provide basic firefighting and department operational knowledge.

You will be asked to participate in the regular activities within this fire department. This includes a minimum response in a 6-month period of 15 on scene calls, and 9 hours of structural firefighting training. The second Thursday and fourth Tuesday of every month starting at 6:00 pm is district wide training. These sessions will serve to introduce you to the fire department's members and likewise them to you. This introduction is important to you as well as other members training along side each other.

There is other training within this department that will be offered. You will not be confined to train out of your station only; you will be welcomed in any of the stations of PCFD.
